NCAER Research Outputs

Monthly Review of the Economy – April, May, and June 2022

The Review of the Economy released every month summarises the economic and policy developments in India; monitors global developments of relevance to India; and showcases the pulse of the economy through an analysis of high-frequency indicators and the heat map.

India Human Development Survey Forum, April, May, and June 2022

The IHDS Forum is a monthly update of publications, op-eds and data news based on the India Human Development Survey (IHDS), which was jointly conducted by NCAER and the University of Maryland in two waves, in 2004-05 and 2011-12. The third wave of the project has also been launched in May 2022. Currently, data collection is going on in Haryana and Punjab.

Study to Assess the Availability of Resources for Creating Assets and Generating Various Own Sources of Revenue in the Gram Panchayats

The main emphasis of the 73rd Amendment of the Constitution of India is to ensure uniformity between the functional responsibilities and the financial resources of the three-tier Panchayati Raj Institutions. In order to become self-reliant and help achieve Gram Swaraj, the Panchayats need to generate Own Source of Revenue through the collection of taxes, fees, and dues as per the powers accorded to them by Article 243-H of the Indian Constitution. Against this backdrop, NCAER undertook an evaluation study to assess the status and challenges faced by the Gram Panchayats in generating revenue and creating resources through a primary survey carried out in 5042 GPs located in 146 districts across 23 States.

Economic Viability of Gaushalas for Production and Promotion of Bio-Fertilisers

A new project on Improving Economic Viability of Gaushalas for Production and Promotion of Bio-Fertilisers has been initiated at NCAER. This study aims to devise innovative ways and policy to promote cattle economy and use of cow manure as biofertiliser and bio-energy especially for Gaushalas to convert cattle into economic assets and to explore the Public Private Partnership model with various stakeholders.
