#### India Human Development Survey Forum Newsletters, December 2021 and January 2022

The IHDS Forum is a monthly update of publications, op-eds, and data news based on the India Human Development Survey (IHDS), which was jointly conducted by NCAER and the University of Maryland in two waves, in 2004-05 and 2011-12. Preparations are underway for launching the third wave soon.

#### India Covid-19 Poverty Monitor, January 2022

The *India Covid-19 Poverty Monitor* bulletin has been compiled by the NCAER National Data Innovation Centre and The Chronic Poverty Advisory Network (CPAN) hosted at the Overseas Development Institute (ODI) in London, using a combination of original qualitative data collected from a small number of affected people in India, interviews with local leaders and community development actors, and secondary data from a range of different sources. The Bulletin has been authored by S. Pramanik, M. Banerji, D. Tiwari, P. Choudhuri, B. Chouhan, A. Motheram, and A. Lenhardt.

# NCAER Webinar on "Issues Facing Small Investors and What Can They Hope for from Budget 22-23", January 21, 2022

A webinar on issues facing small investors and what they can hope for from Budget 2022-23 was held virtually with Mr Nilesh Shah, Managing Director, Kotak Mahindra Asset Management Co. Ltd, and Mr N.S. Venkatesh, Chief Executive, Association of Mutual Funds in India. The discussion was moderated by Ms Mythili Bhusnurmath, Senior Adviser, NCAER. The webinar was part of the Investor Education and Protection Fund (IEPF) monthly webinar series. NCAER established the IEPF Chair Unit in 2020, with funding from the Investor Education and Protection Fund Authority, Ministry of Corporate Affairs. NCAER's IEPF Chair Unit conducts research on contemporary issues related to investor education and protection, and an analysis of related economic, legal and regulatory issues.

#### Book Launch, The German Chambers of Commerce and Industry, December 21, 2021

NCAER organised a launch of the book, *The German Chambers of Commerce and Industry*, held virtually, with the author, Prof Andrè Habisch of Catholic University Eichstaett-Ingolstadt. The discussion was moderated by Dr Poonam Munjal, Senior Fellow, NCAER. The discussants were Prof Santosh Mehrotra, Visiting Professor, Centre for Development Studies, University of Bath, U.K., and Dr Bornali Bhandari, Senior Fellow, NCAER. This book examines a key factor driving the enduring international success of German companies. Beyond industrial specialisation, peaceful labour relations, local financial markets, and the "Miracle of the Mittelstand", it focuses on a characteristic aspect of governance within the German economy, symbolised by the Chambers of Commerce and Industry.

## NCAER Public Lecture: Global Recovery from the Pandemic Policy Challenges in 2022, December 15, 2021

NCAER hosted a lecture by Dr Gita Gopinath, Chief Economist at the International Monetary Fund. Dr Poonam Gupta, NCAER Director General, chaired and moderated the session. The talk by Dr Gopinath focused on the outlook for global growth in the year to come. As the global economy recovers from the pandemic, a great deal of uncertainty remains about new COVID-19 variants and

increased inflation pressures in many countries. Dr Gopinath discussed how policymakers can best deal with these challenges in an increasingly uncertain environment.

### Conversations with NCAER, "Recalibrating the Insolvency and Bankruptcy Code", December 14, 2021

This webinar on 'Recalibrating the Insolvency and Bankruptcy Code' was the third of NCAER's monthly webinar series titled 'Conversations with NCAER'. NCAER hosted Shri Jayant Sinha, Member of Parliament, Lok Sabha, Mr M.S. Sahoo, Former Chairperson, Insolvency and Bankruptcy Board of India (IBBI), and Mr Pallav Mohapatra, CEO, ARCIL, for this conversation. The discussion was moderated by Ms Mythili Bhusnurmath, Senior Adviser, NCAER.

#### Launch Announcement: NCAER Gig Economy Initiative, December 7, 2021

NCAER launched a new NCAER research programme on the "Gig Economy". The proposed programme seeks to holistically analyse the socio-economic impact of the platform economy in India. The research programme is divided into two phases. In the first phase, it entails a study of the food delivery sector including delivery partners, restaurants, and platform providers. The second phase will involve an assessment of the impact of platforms' adoption on firms, especially on workers. The research programme is supported by Prosus. The keynote address at the launch was delivered by Mr Sunil Barthwal, Secretary to the Government of India, Ministry of Labour and Employment.

# The Japanese Debt Sustainability and Fiscal Reforms – Possible Implications for Indian Fiscal and Tax Policy, January 28, 2022

In this NCAER seminar, Mr Usami Koichi, of the Embassy of Japan in India, discussed fiscal debt sustainability, an issue of concern for most governments, regardless of their sizes, income levels, and developmental phases of the economies in their respective countries. The seminar highlighted the current state of the fiscal situation in Japan, analysed structural drivers behind the accumulated debt, and discussed the recent reforms in the country.

# The Political Budget Cycles in the Presence of a Fiscal Rule: The Case of Farm Debt Waivers in India, January 21, 2022

The participants at this NCAER seminar included Vidya Mahambare (Great Lakes Institute of Management, Chennai), Sowmya Dhanaraj (Madras School of Economics), and Pragati Mittal (Madras School of Economics). They discussed the issue of farm debt waivers meant to signify a one-time settlement of loans. Their paper finds that the timing of waiver announcements by State governments between 2001-02 and 2018-19 is associated with the timing of elections after controlling for variables related to farming distress.

#### Launch of Gender Data Hub by NDIC

The NCAER National Data Innovation Centre (NDIC) is launching a gender data hub supported by a five-year grant from Co-Impact. This hub will focus on research supporting evidence-based policy design from a gender perspective. It will serve as a resource for researchers, policy-makers, civil society representatives, and journalists by undertaking gender-focused analyses of data in areas of livelihoods, health, education, and family formation. Activities undertaken by this hub will include enhancing access to data collected by NCAER, visiting fellowships for practitioners and researchers, and seminars addressing strategies for incorporating a gender lens in data collection processes. Sonalde Desai, Professor, and Centre Director, NCAER-NDIC, and Pallavi Choudhuri, Fellow, NCAER-NDIC, will lead this initiative.

#### **IHDS-3 Field Testing**

The NCAER NDIC team, led by Dinesh Tiwari and Om Prakash Sharma, conducted field testing of the India Human Development Survey-3 (IHDS-3) CAPI survey instruments in two villages in Alwar

district of Rajasthan during 14-17 December, 2021. The objective of this activity was to test the flow, relevance, functionality, survey duration, and respondent burden for all the household questionnaires (Income and Social Capital, Education and Health, Marriage and Fertility of Eligible Woman, Anthropometry Measurement and Learning Test of children aged 8-11 years) along with feasibility of data uploading in a remote connectivity setting.
